218. GRADUATION REQUIREMENTS

REVISED:

1. Purpose

The Board will acknowledge each student's successful completion of the instructional program appropriately to the student's interests and needs by awarding a diploma at the graduation ceremonies.

2. Authority School Code §§ 1611, 1613; 22 Pa. Code §§ 4.24 The regulations instituted by the Pennsylvania Department of Education and Catasauqua Area School District shall be the minimum requirements for graduation from Catasauqua High School.

The credit and other requirements for graduation from Catasauqua High School are specified in the Catasauqua High School Career Planning Guide and Catasauqua High School Handbook approved by the Board of School Directors. The Career Planning Guide and Handbook will be reviewed and updated annually. A copy of the requirements shall be published and distributed to students, parents and guardians. Copies of the requirements also shall be made available in each school building or on the School District's publicly accessible web site.

Changes to high school graduation requirements shall be published and distributed to students, parents and guardians and made available in each school building or on the School District's publicly accessible web site immediately following approval by the Board of School Directors.

A student who has completed the requirements for graduation shall not be denied a diploma as a disciplinary measure, but the student may be denied participation in the graduation ceremony when personal conduct so warrants. Such exclusion shall be regarded as a school suspension.

Seniors not meeting the requirements for graduation are not permitted to participate in the commencement program.
